This Claim Form must be completed if you are a member of the Refund Class who wishes to receive a complete reimbursement of their order, minus the amount to be legally withheld on behalf of the *Fonds d'aide aux actions collectives*.

To be eligible, the Claim Form must be submitted at the latest by the **Claims Deadline: November 6, 2022**. No claim will be accepted after this date and you will have lost your potential right to compensation pursuant to the settlement.

The refund will only be provided if the valid ticket(s) is returned to the Defendant by the end of the Claims Period (**November 6, 2022**), and at least 48 hours prior the event date. Methods of returning the ticket(s) can be found on the Settlement Website at www.vssettlement.ca. If an order entailed the purchase of multiple tickets, all of the tickets that formed part of the order must be sent altogether.

The refund will be credited to the method of payment used to purchase the tickets (in USD) within 80 days of the Filing Deadline. If this method of payment has expired, you will be contacted to obtain a new method of payment to credit.
